**Subject:** Amendments to the Cook Islands Ship Owners Association (CISOA) and Cook Islands Yacht Squadron (CIYS) Application Forms to include PurpleTRAC Vetting & Sanctions Compliance

Date: 22<sup>nd</sup> August 2018

#### Summary:

The CISOA and CIYS Application Forms have been amended so that Maritime Cook Islands complies with its obligations under the Cook Islands Financial Transactions Reporting Act 2018. CISOA Application Form version 5 and CIYS Application Form version 9 will replace existing CISOA and CIYS Application forms.

Additional procedures as described below will be implemented upon application for Membership, as of the 01<sup>st</sup> of September 2018.

#### **Sanctions Compliance**

- The Cook Islands Ship Registry will enforce all UN mandated Sanctions. The list of sanctioned countries, individuals and entities can be found at <a href="https://www.un.org/sc/suborg/en/sanctions/un-sc-consolidated-list">https://www.un.org/sc/suborg/en/sanctions/un-sc-consolidated-list</a>
- 1) The following items need to be checked;
  - a) Is the owner of the vessel domiciled in a sanctioned country?
  - b) Is the owner of the vessel associated with a sanctioned individual/entity?
  - c) Has the vessel traded with or called on any port in a sanctioned country?
- 2) In the case that the vessel is owned by a Cook Islands incorporated international company or registered foreign entity via a Cook Islands Trust company, MCI can rely on the due diligence carried out by the Trust company and is not required to consider 1) a & b above.
- 3) In the case that the vessel is owned by a member of CIYS or CISOA then CIYS or CISOA must conduct due diligence on 1) a & b above.
  - a) The Registry will rely on the declaration in the revised CIYS or CISOA membership application forms in the first instance. Applicants must declare the domicile of the owner, the beneficial owner and that no associates of the vessel or owner are connected to any sanctioned entity or individual.
  - b) Prior to permanent registration the fleet manager must run an additional PurpleTRAC report, which will identify the owner under the Cook Islands flag and highlight any risks associated with that owner.

In all cases the Registry will require confirmation that a vessel has not traded with or called on any port in a sanctioned country. This will be obtained by running a PurpleTRAC report at - https://www.purpletrac.com/.
